关于“防范打击通讯信息诈骗专项行动”的相关通知

Notification of Special Actions to Prevent Fraud in Communication and Information

根据工信部《工业和信息化部关于进一步做好防范打击通讯信息诈骗相关工作的通知》（工信部网安函[2015]601号）要求，运营商开展整顿规范重点电信业务经营秩序，坚决遏制虚假主叫传输与改号软件传播，要求客户资料符合实名登记制度，客户号码用途须与该企业证件上登记的经营范围保持一致，客户传送的主叫号码为电信分配的号码，且主叫号码的传送是真实的，客户不得显示非运营商分配的外呼主叫号码、不得私自修改显示主叫号码、不得显示虚假主叫号码，烦请贵企业（机构）知悉并配合落实。

另外，所有分配号码的使用地必须为中国境内，不允许在境外使用号码。

According to the Ministry of Industry and Information Technology's "Notice on further preventing and Combating Communications and Information Fraud" (Ministry of Industry and Information Technology, No. [2015] No. 601), carriers have rectified and standardized the order of crucial telecommunications business operations and has resolutely curbed false masters. Call transmission and number change software dissemination, customer information is required to comply with the real-name registration system, the use of customer numbers must be consistent with the business scope registered on the corporate certificate, the calling number transmitted by the customer is a number assigned by telecommunications and the transmission of the calling number. Indeed, customers are not allowed to display outbound caller numbers that are not designated by telecommunications, they are not allowed to modify and display caller numbers, and they are not allowed to view false caller numbers. Your company (institution) is requested to know and cooperate with the implementation.

Furthermore, all numbers should be used in China only, and using numbers outside China is prohibited.

1. 本企业（机构）不利用该业务传播非法内容或泄露国家机密，不操作国家及工信部不允许的业务。

The enterprise (institution) does not use this service to spread illegal content or leak state secrets and does not operate facilities that are not allowed by the state and the Ministry of Industry and Information Technology.

2. 本企业（机构）在使用该业务时将严格按照国家主管部门批准的用途、国家法律、法规的规定以及合同的约定，不用于任何违规违法经营；也不以转租、转包、转让、转售等任何方式提供给第三方使用。

The enterprise (institution) will use the business strictly by the use approved by the competent national authority, the provisions of national laws and regulations, and the contract, and will not be used for any illegal or illegal operation; Resale, etc. to any third party.

The agreed calling name, false calling number, and illegal calling number; promised that its platform (small exchange) does not use the calling number of other places for cross-provincial outbound calls. Promise not to make multiple transfers and do not evade number tracing and screening.
